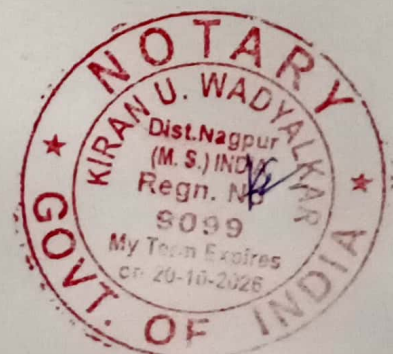

Sub:- For the purposes of section 18 of the Right of Children to Free and Compulsory Education Act, 2009, regarding the issue of recognition certificates to schools subject to rule 11 pot rule (4) of the Right of Children to Free and Compulsory Education Rules, 2011

With reference to your application dated 18/11/2022 I myself Rohini Kumbhar, Education officer (Primary) Zilla Parishad Nagpur after verification / inspection & correspondence of the school I hereby grant provisional permission for Std 1 to std – 8 to Era International School, (English Medium) Revati Nagar, Besa Road, Nagpur for the period of 01/04/2022 To 31/03/2025 for three years.

Above said permission is subjected on the basis of following Terms and Condition.

- 1) NO EXTENSION OF PERIOD OF APPROVAL There shall be no obligation under any circumstances to grant approval or affiliation after Class 8.
- 2) The school shall comply with the provisions of Right of Child to Compulsory Education Act 2009 (Appendix 1) and Maharashtra Right of Children to Free and Compulsory Education Rules 2011 (Appendix 2).
- 3) It is compulsory to the school to allocate 25% seats for weaker section students & indigent in Std- 1 of intake capacity of said class. It shall be compulsory Free and Compulsory Education up to completion of primary education. However It has also noted that for free Primary Education same should be followed.



- 4) For the children specified in paragraph 3 the school shall receive reimbursement in accordance with section 12(2) of the Act. An Independence Bank account will be provided to the school to receive such reimbursement
- 5) The Trust/ School shall not charge any capitation fee and shall not compel the child or his parents or guardians for any examination procedure.
- 6) No child shall be denied admission to school for want of proof of age, religion, caste or race, place of birth or any of these grounds.
- 7) 1) No child admitted to school shall be held back in the same grade as he is or expelled From school till completion of primary education.
2) No child shall be subjected to corporal punishment or mental torture
3) It is not binding for students to pass any type of board exam. Unless he is not Completed their primary education.
4) Child is to be awarded a certificate under section 23 for completion of primary Education.
5) Merge of handicapped and special need students be allocated as per the Act.
6) Teachers possessing the minimum qualification prescribed u/s 23(1) of the Act shall be Appointed, provided further that teachers possessing the minimum qualification on the date of commencement of the Act shall acquire such minimum qualification within a period of 5 years.
7) A teacher shall perform his/her duties specified in Section 24(1) of the Act.
8) The school shall ensure that the teacher does not engage himself in private tutoring activities.
- 8) The school shall follow the syllabus prepared on the basis of the syllabus prescribed by the appropriate authority.
- 9) The school shall admit students against the facilities available in the school as prescribed in section 19 of the Act
- 10) Following are the facilities available in the school at the time of last inspection which will comply with the standards and norms specified in Section 19 of the Schools Act.

1. Area of school	:-	44,000 sq. ft.
2. Total Constructed Area	:-	18,000 sq. ft
3. Area of Playground	:-	22,000 sq.ft.

7. Drinking water facility :- Available (RO Water)
8. Kitchen to cook lunch :- Not applicable
9. Availability of Teaching-Study Materials / Sports and Sports Materials / Library :(- Map, Chart, Math Box, science box)

12. Does the school have a protective wall :- Yes
- 11) Unapproved classes or units will be held on school premises or elsewhere are not.
- 12) The school building or other construction or playground shall be used for the purpose of education and skill development.
- 13) The school is run by a body registered under the Society Registration Act 1860 (21 of 1860) or the Bombay Public Trustee Act 1950.
- 14) The school is not run for the benefit of any group or association of persons or any other person or for making any profit.
- 15) The accounts of the school should be audited and certified by a Chartered Accountant and proper statement of accounts should be prepared as per rules. A copy of each account statement should be sent to the District Education Officer every year.

- 17) The school should submit such reports and information as may be demanded by the Director of Education/ District Education Officer from time to time or follow the instructions given by the Government or the local authority for continuous fulfillment of the condition of recognition of the school or to remove the errors in the functioning of the school.
- 18) Any renewal of the organization's registration should ensure renewal



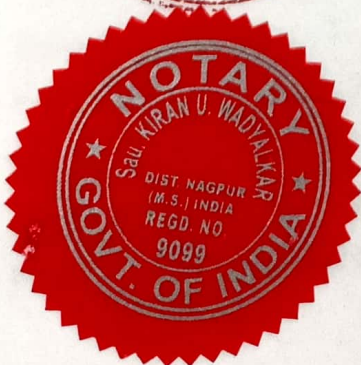
